\$12M Transportation Project Funds (TPF) Awarded to EPCOG Region

On August 18th, 2022, the NM State Transportation Commission met in Farmington, NM, and voted on the final list of awards for the Transportation Project Funds. The project fund will grant money up to 95% of the project costs. Local entities must provide the remaining 5% match to their respective projects. Local governments may receive match waivers from the State to assist with the project based on the local government's budget restraints. The State is also funding projects that have shortfalls to bring projects to completion. NMDOT tasks EPCOG to assist local governments with TPF applications.

Twelve (12) local governments within the EPCOG region are awarded from the State an expected total of \$12,781,798.97 for transportation infrastructure. Among these awardees are the City of Portales, Curry County, Roosevelt County, Town of Vaughn, City of Santa Rosa, City of Tucumcari, Guadalupe County, Town of Clayton, Village of Roy, Village of Logan, Village of San Jon, and Quay County.

EPCOG is honored to assist the region with much-needed transportation infrastructure. We thank our state legislators and NMDOT for the continued support for rural New Mexico.
